WHITE HILLS HAMLET SANDHURST

In pursuance of the Act of Council, 18 Victoria, No. 15, his Excellency the Officer administering the Government has, with the advice of the Executive Council, directed the publication of the substance or prayer of a petition to his Excellency herein and forth, signed by one hundred and fifty four house holders resident in the White Hill Hamlet, Epsom, Huntly and adjacent districts.

The petitioners pray as follows:-

"We the undersigned inhabitants of the White Hill Hamlets, Epsom, Huntly and adjacent districts, most respectfully beg your Excellency will be graciously pleased to cause the above mentioned district, commencing at a point between portion C. of the township of Sandhurst and the White Hill Hamlets, (such starting point to be left to the decision of the Surveyor General) and extending northwards not more than six miles, to be proclaimed a separate Municipal District according to the provisions of the Act of Council, 18 Victoria, No.15, intituled 'An Act for the establishment of Municipal Institutions in Victoria'.

"And your Memorialists, as in duty bound will ever pray".
